1. This Corrigendum is being issued by HP Ecotourism Society in relation to the Request for Proposal Document issued for “***Selection of an Operator for Design, Development, Management/ Providing Services to run Eco-Tourism Activities at Kasol in Parvati Forest Division of Kullu Forest Circle in the State of Himachal Pradesh***” (RFP Reference No. Ft/ET/RFP/Kasol/195/06 dated 15.01.2024) on the web portal <http://hptenders.gov.in/> on 15.01.2024. The purpose of this Corrigendum is to notify all Bidders about the revision/ modification required to be made to the Request for Proposal Document and Draft Concession Agreement.
2. **Clarification:**
  - (i) The area of Ecotourism Site at Kasol has been specified as 0.96 (zero point nine six) hectare in the Request for Proposal Document and Draft Concession Agreement uploaded on the portal. However, the area of the Ecotourism Site at Kasol be now considered as 1.00 (one) hectare approx.
  - (ii) Further, Bidders are strongly advised to visit the site before submitting their bids in order to assess the Ecotourism Site where the Project is to be implemented. In this regard, the Bidders should contact the Nodal Officers/ DFOs whose contact details are specified in this Corrigendum.
  - (iii) Schedule-A (Particulars of Ecotourism Site) in the Draft Concession Agreement stands deleted. Therefore, Bidders to note that any reference to Schedule-A appearing anywhere in the Draft Concession Agreement shall have no relevance.
